- NO: number of the course on the offer
- CODE: it has to be provided in the Learning Agreement and will help to identify the course in the enrolment system
- COURSE: the title of the subject
- ECTS: credits assigned to the course upon successful completion. It is not possible to take partial educational elements of the course (e.g. only lectures) and receive partial credits for it
- GRADING: all courses are concluded with a grade; however, in some cases, additional exam needs to be taken (in the examination period after the semester)
- LEVEL: study level in Wroclaw. **The WUEB does not restrict the participation of Master-level students in Bachelor-level courses and vice versa. This is left to be decided by coordinators from the home institutions.**
- PROGRAMME: Study area in which the course is included and the year when a current group of students started their education (the year is needed to identify the valid version of the syllabus for 2026/27). **The WUEB allows exchange students to take part in courses of all programmes.**
- YEAR: year of studies. **The WUEB allows exchange students to participate in courses of all study years.**
- SEMESTER: indication of a semester when the course is held. Most of the courses, except for those dedicated to exchange students, are held only in one semester
- TYPE: indicates whether the course is included in the core programme or a specialised module consisting of several courses. **The WUEB allows exchange students to take part in individual courses within modules.**
- AVAILABLE PLACES: expected number of free places in courses (the actual numbers may be different). For 1st-year courses, the limits are known only in September. **The WUEB does not guarantee exchange students a place in a course, even if their initial Learning Agreements are accepted.**
- TH / L / T / C – total class hours / lecture hours / tutorial hours / computer lab hours

- TYPE: All Erasmus-dedicated courses belong to electives. The number in brackets indicates the minimum number of participants required to open the course.
- WINTER / SUMMER: a form of delivering classes dedicated to exchange students. If students want to participate in a **VIRTUAL MOBILITY**, they need to select the courses marked as **online** only.

## 2. Preparation of the Learning Agreement

The study programme in each semester should include a **minimum of 3** and a **maximum of 10 subjects** worth a **minimum of 15 ECTS** and a **maximum of 35 ECTS**. No exceptions from this rule will be considered.

All (Online) Learning Agreements signed before mobility should be treated as **provisionally accepted**. Only **after enrolment in courses** will they be considered binding.

**NOTE (1):** Although Wroclaw University of Economics and Business prepares sufficient course slots for all international students, **we do not guarantee a place in all courses included in the initial Learning Agreement**, also due to possible time clashes when courses from various types of offers, programmes, study levels and years are selected. Moreover, the University **reserves the right to amend** its educational offer after its publication.

**NOTE (2):** Wroclaw University of Economics and Business expects exchange students to **consult their study programmes with coordinators at Sending Institutions**. We do not **acknowledge responsibility for mistakes in formulating the Learning Agreement**, in particular, including courses not listed in the current academic offer of WUEB (using wrong course names or codes, selecting courses from the wrong semesters) or attributing the wrong number of ECTS points to a course.

**NOTE (3):** Wroclaw University of Economics and Business insists on **preparing the Learning Agreement in one format only**, preferably the **Online Learning Agreement using the Erasmus Without Paper platform** or the **Learning Agreement generated in the IRK registration system** administered by the University. We refrain from signing the Learning Agreement or similar documents if they are not formulated entirely in English.

**NOTE (4):** The Learning Agreements **will be accepted only if they include** the **student's data**, the **List of Courses** selected to study at Wroclaw University of Economics and Business with their **Course codes** and **ECTS points**, **signatures of a Student and a Coordinator** at the Sending Institution.

- Exchange students are allowed to build the study programme according to the following rules:
  - The programme in each semester should include a **minimum of 3 subjects** and a **maximum of 10 subjects** worth a **minimum of 15 ECTS** and a **maximum of 35 ECTS**
  - In the case of **annual mobilities**, the ECTS credits will not be summed up (the limits above apply to each semester)
  - The programme may consist of subjects from various types of offers, programmes, study levels and years, provided that a coordinator of a home institution accepts them
  - The programme does not include foreign languages (other than Polish), bachelor/master seminars, or sports classes
- The **actual course enrolment** is organised two/three weeks before a semester starts
  - If an exchange student cannot enrol on a course included in their initial Learning Agreement, they will be offered the possibility to select other courses available in the offer with free places

- Each student is entitled to introduce changes to the study programme within **the first two weeks of the semester**
- **After the two-week period**, the following rules apply:
  - It is not allowed to be unenrolled from the course which starts in T1, only those which start in T2, and not later than a week before T2 starts
  - It is not allowed to be enrolled on a course which starts in T1, only those which start in T2, and not later than a week before T2 starts
  - It is not allowed to reduce the number of credits **below 15 ECTS** or **exceed the maximum of 35 credits** in one semester
  - In exceptional situations, and **only on the request of coordinators of home universities**, **send via email** to the Academic Coordinator of WUEB, other changes may be considered
- The documents accepting changes during mobility will be **signed within the first month** of the mobility

### 3. Types of courses and classes

- Regular BA/MA programmes in English
  - including the following study fields: Business Informatics (BA), Business Management (BA/MA), Finance (BA/MA), International Business (BA) and Management Accounting (BA)
  - always on offer
  - attended by regular (not only Polish) students and exchange students
  - may consist of separate class formats: lectures, tutorials, computer labs and be split into groups
  - may be concluded with PASS or EXAMS (in the examination session)
  - schedule can be found here: <https://plan.ue.wroc.pl/index.php?l=en> (select the academic year as indicated next to each subject)
  - syllabi: <https://ue.e-sylabus.pl/ForStudents> (switch to English by pressing EN button)
- Courses in English within the programmes for Polish students
  - offered within various study fields
  - always on offer
  - attended by regular Polish students and exchange students
  - consist of lectures only (with few exceptions)
  - are concluded with a PASS
  - schedules and syllabi are available via the same links as the Regular BA/MA programmes in English
- Courses dedicated to exchange students
  - attended only by the exchange students
  - opened, if a minimum of 12 students select them. The number of places is limited to 30/32 per course.
  - more flexible timetables and class formats
  - not divided into class groups (with possible exceptions)
  - concluded with a PASS (assignment or test before the examination session)
  - schedules and syllabi are distributed directly to exchange students

#### 4. Participation in classes

- The courses selected by exchange students **must not overlap**. It is essential to consider that selecting courses from various types of offers, programmes, study levels and years **may lead to time clashes**. Therefore, it is **suggested that replacement options be considered** with the home coordinators.
- Class **participation** (in **tutorials** and **computer labs**) **is mandatory**, and in **lectures**, recommended. The following rules apply:
  - Students have the right to justify their absence due to health problems if a sick leave is presented
  - Taking part in activities outside the University (e.g. travelling, working, etc.) is not considered a justified absence
  - If students fail to attend the classes multiple times (3 or more), they may receive a 2,0 (failed) grade without a possibility to resit the course

#### 5. Forms of assignments

- During the semester (ordinary grades/points)
  - course instructors may freely decide the grading formats,
  - they include, e.g., control work (problems to solve, tests), individual or group projects, in-class activity, etc.
- End of the semester (so-called PASS)
  - should be organised at the end of the semester (before the examination session)
  - have a form of multiple-choice or open tests, a set of problems to solve
  - the course instructor may resign from that format and calculate the final PASS grade based on class points
- During the examination session (so-called EXAMS)
  - are organised after the semester
  - will usually have the form of 'big exams' with multiple problems to be solved
  - require obtaining a PASS in all class forms (in particular tutorials and labs) before taking the EXAM

#### 6. Grading system

- All courses at WUEB are concluded with grades awarded as in Table 1
- The final positive grade is obtained when all class formats (lecture, tutorials, labs) are concluded with a positive grade
- The final grade is calculated as a weighted average of class grades (using the scale as in Table 2):
  - Lecture (50%) + Tutorials OR Labs (50%)
  - Lecture (50%) + Tutorials (25%) AND Labs (25%)
- All **failed grades** (and only failed grades) may be improved in **one RESIT take**, in the same semester, **immediately after the main exam session**
  - if a student fails to obtain a PASS, the final EXAM counts as RESIT (only one take, instead of two)

## 7. The organisation of the academic year

- The academic year is divided into two semesters (winter/summer), each consisting of 16 class weeks
- Each semester is divided into two sub-semester (T1/T2). Some courses expand over one sub-semester (T1/T2), some over both (T1+T2 = N)
- Winter semester
  - class schedule: published in the first week of September
  - class start/finish: the beginning of October / the first week of February
  - examination session: the second week of February until the end of the third week of February
- Summer semester
  - class schedule: published in the first week of February
  - class start/finish: the last week of February / the third week of June
  - examination session: the last week of June and the first week of July

## 8. Level of English

- Wroclaw University of Economics and Business expects exchange students to represent a **B2 level of English**, which should be confirmed with an official language certificate or any document provided by Partner Universities.
