



DOCUMENTS REQUIRED FOR UNIVERSITY REGISTRATION	
1.	Acceptance Letter
2.	Bank receipt showing that the tuition fee for the fall semester has been paid on behalf of the applicant.
3.	Original and Photocopy of the High School Diploma <i>The diploma must bear an apostille certification, or an equivalent form of authentication in countries that are not parties to the Apostille Convention. Documents in languages other than Turkish or English must also be accompanied by a Turkish translation</i>
4.	Original and the copy of High School Transcript (Grade Report) <i>The Transcript must bear an apostille certification, or an equivalent form of authentication in countries that are not parties to the Apostille Convention. Documents in languages other than Turkish or English must also be accompanied by a Turkish translation.</i>
5.	Document showing the numerical equivalent of letter grades for those whose graduation grades are not specified numerically on the high school diploma.
6.	High School Diploma Equivalency Certificate <i>High schools for which an equivalency certificate is not required/ Reason for exemption: YTB Schools <input type="checkbox"/> KKTC <input type="checkbox"/> T.C. High School <input type="checkbox"/></i>
7.	Original exam result (If available) <i>Applicants who apply with predicted GCE A Level scores are required to submit their final results certificate.</i>
8.	Two (2) biometric photographs measuring 4.5 x 6 cm.
9.	Original Passport and a Photocopy of the Valid Visa Page <i>Those with a diplomatic passport or a blue card are not required to provide a visa. Those residing in Turkey should also provide a photocopy of their residence permit. Photocopies of the pages containing passport identification information, the visa, and the stamp indicating the date of entry into the country will be required.</i>
10.	Civil Registration Certificate <i>For dual citizens with Turkish citizenship, a population registration showing that their primary nationality is not Turkish.</i>
11.	The applicant's special identification document. [] Temporary or international protection identity card. [] Blue Card and the document showing the date of renunciation of Turkish citizenship. [] Document showing that citizens of the Turkish Republic of Northern Cyprus (TRNC) with a second nationality have renounced their Cyprus citizenship.
12.	Document showing the entry-exit dates to Türkiye for students who have gained admission under the quota for Turkish citizens who completed their high school education abroad (Can be obtained from the address turkiye.gov.tr using an e-Devlet password.)
13.	Certificate of language proficiency relevant to the language of instruction of the applied program (If available)
14.	Medical Report <i>Medical report from a hospital in Türkiye indicating that you carry no contagious diseases.</i>
15.	Medical report from a fully equipped hospital in Turkey, indicating that the health condition is suitable for studying in the Coach Training (TR) and Sports Management (TR) programs.
16.	Medical report from the healthcare institutions listed in the link below, confirming that the health condition is fit for flight, required for the Civil Aviation and Cabin Services (TR) program. https://web.shgm.gov.tr/documents/sivilhavacilik/files/pdf/saglik_birimi/YHTM-18-04.pdf
17.	Power of Attorney (If available) <i>The power of attorney must bear an apostille certification, or an equivalent form of authentication in countries that are not parties to the Apostille Convention. Documents in languages other than Turkish or English must also be accompanied by a Turkish translation</i>
