Ankara Yildirim Beyazıt University Faculty of Law and the Research and Application Centre of Commercial and Intellectual Property Law will host a two-day fully virtual symposiums starting with the “IV. International Symposium of Commercial Law” on **October 25,2021** followed by the “IV. International Symposium on Intellectual Property Law” on **October 26,2021**.

The calls are open to all practitioners, academics and researchers with free registration.

The theme of the IV. International Symposium of Commercial Law is “**Interdisciplinary Approach to Commercial Law**”. It is expected that the papers must adopt an interdisciplinary approach for commercial law and related issues, such as bringing issues from corporate law and law of civil procedure or labour law together. Joint studies by more than one researcher in different fields will be preferred.

The theme of the IV. International Symposium on Intellectual Property Law is “**Copyright in the Information Society**” that covers all kinds of issues related to copyright in the information society. Some of the main headings can be listed as follows: Data mining, online education, cultural heritage, extended licensing, digital platforms, works with expired protection, press publishing, online platforms, affordable prices, etc.

The papers must not have been previously presented or published elsewhere. Papers and their presentations must be in Turkish or English. No translation services will be provided.

Paper abstracts must be in the range of 300-400 words. Authors are kindly requested to provide their institutional affiliations and contact information, including their e-mail addresses and cell phone numbers.

Both the abstracts and the full texts of the papers will be subject to peer review. Whilst the abstracts of the papers will be published by the University in an electronic book format, full texts of the papers will be published in Ankara Yildirim Beyazıt University’s Journal of Commercial and Intellectual Property Law. Full texts of the papers presented at the symposiums must be prepared in the form of an article and accordance with the author guidelines of the Journal of Commercial and Intellectual Property Law available at dergipark.org.tr/tfm.
