**SUBJECT AND PURPOSE OF THE SYMPOSIUM**

There has arisen great need to address the problems emerging in the enforcement of Turkish Commercial Code No. 6102 after its entry into force in 2012, and to offer solutions to these problems. Accordingly, I. International Symposium on Commercial Law was held on 27<sup>th</sup> November 2014. Turkish and German academics from various research areas came together to discuss certain issues in Turkish and German law. Moreover, the academic atmosphere at the 2014 Symposium was perceived so strong that there became necessity to organise another symposium and to maintain the path annually. As a result, Yıldırım Beyazıt University, Faculty of Law is going to organise “II. International Symposium on Commercial Law” to be held on 26<sup>th</sup> November 2015. At the 2015 Symposium, papers on “*Management of Joint Stock Companies*” will be presented by researchers participating from Turkey and other countries. At the Symposium, papers will be presented in Turkish, English and/or German and moreover simultaneous translations will be provided. The Symposium is open to all academics and researchers who are interested in the topic.

**SYMPOSIUM CALENDER**

Researchers and academics who would like to present their papers on “*Management of Joint Stock Companies*”, which is the subject of the 2015 Symposium, are requested to submit their abstracts to **commerciallaw@ybu.edu.tr** in the pdf format until 10<sup>th</sup> August 2015. Selected abstracts will be announced on 1<sup>st</sup> September 2015. The exact programme of the Symposium will be announced by 1<sup>st</sup> October 2015. Full texts of selected papers that will be presented at the Symposium, which is going to be held in Ankara on 26<sup>th</sup> November, need to be sent by 9<sup>th</sup> November 2015. Both summaries and full texts of papers will be subjected to peer-review. Papers must be in the article format, and be prepared in accordance with the publication principles of the “*Journal of Commercial and Intellectual Property Law*” [“*Ticaret ve Fikri Mülkiyet Hukuku (TFM) Dergisi*“]. Following the peer-reviewing, selected abstracts will be published in the “*Journal of Commercial and Intellectual Property Law*” in 2016.

Accommodation (max. of 2 nights) and travel expenses (economy class flight) of all speakers will be financed by Yıldırım Beyazıt University.
